Village of Glenview On-Street Temporary Parking Permit

To qualify for an **Annual On-Street Temporary Parking Permit**, the applicant must meet the following criteria:

- Not enough off-street parking for the number of vehicles in your household e.g., 5 cars in household, 2 car garage and 2 car driveway = eligible to apply for 1 permit
- The shuffling of multiple vehicles in driveway and/or garage is not considered a hardship.
- All vehicles must have valid Illinois license plates which register to the address seeking the permit
- The need for on-street parking exceeds 30 days

DISCLOSURE AND ACKNOWLEDGEMENT:

The undersigned hereby acknowledges and agrees that he/she shall be responsible for moving the vehicle associated with this permit from time to time during or following the accumulation of 2 inches or more snow during any 24 hour period ("Snow Event") to allow Glenview Public Works the opportunity to maintain public streets, including, without limitation, clearing the roadway of snow accumulation and allowing street salting operations. This includes making every attempt to avoid parking my vehicle opposite another parked vehicle during a Snow Event and periodically moving my vehicle during or immediately following a Snow Event so a street may be cleared of snow. I agree to be bound by these conditions as part of the issuance of this permit and understand that this permit is expressly conditioned upon my compliance with the foregoing. Non-compliance with these conditions may result in the revocation of this parking permit, at the discretion of the Village of Glenview. By signing below, the undersigned waives and releases any and all claims, known or unknown, against the Village of Glenview related to any injuries, property damage, or losses that may directly or indirectly result from the issuance of this permit or the use or maintenance of on-street parking facilities.

Permits are non-transferrable. Permit holders that attempt an unauthorized permit transfer are subject to citation, fines, and penalties, and may have their permit terminated by the Village.
