In accordance with recent amendments to the Open Meetings Act, this meeting will be conducted by audio or video conference means without a physically present quorum of the Board of Trustees because of a disaster declaration related to COVID-19 and public health concerns affecting the Village of Glenview. The Village President has determined that an in-person meeting at Village Hall is not practical or prudent because of the disaster. Physical attendance at Village Hall by the public is also not feasible because of the disaster.

The Village has developed a number of options to allow members of the public the opportunity to participate. Information on how to view and attend a “virtual meeting” of the Board of Trustees is available below. Although the meeting will be held virtually, members of the public will still be able to submit comments both in advance and during the meeting. Please note the guidelines for attendance and public comment below.
