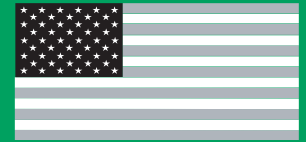

Pay Your Utility Bills On-Line (With No Service Fee!)

Looking for a way to simplify your life? Now, you can save a stamp or skip a visit to Village Hall by using the Village's new **on-line utility bill payment system!** Our new Citizen Self-Service (CSS) system has **no credit card service fee** and offers you the convenience of managing and paying all your water and sewer bills with the click of the mouse. Here's what you need to know -- and a few frequently asked questions.

Wasn't On-Line Bill Pay Already Available?

For some time, the Village has offered on-line utility bill payment through the State's E-Pay system, which charges a convenience fee. The new CSS system carries no additional fee. **You pay only the amount you owe for water and sewer service.**

How Does it Work?

It's easy to do:

- Be sure you have your **account number** available (you'll find it near the top of your bill).
- Log onto www.glenview.il.us and choose the **"Online Payment"** button at the top of the Home Page.
- From the Electronic Services page, choose the **"Citizen Self Serve"** link.
- Once you arrive at the **CSS portal** (see image on this page), choose "Utility Bills" from the menu on the left.
- Enter your account number -- and you're ready to go!

From this point you can pay your water and sewer bills -- and even view your consumption history.

What Forms of Payment Can I Use?

The CSS system will accept MasterCard and Visa (credit and debit cards are both fine). The State's E-pay system

accepts American Express, Discover, MasterCard and E-Checks (this is one reason why the Village continues to offer the E-Pay option to residents.)

Are My Payments Secure?

Yes. The Village uses the same security system used by many major banks. In fact, for security reasons, the system does NOT store your credit card number. You will need to re-enter it each time you use the CSS system.

Is The Automatic Debit Program Still Available?

Yes. If you currently use the Village's automatic debit program to pay your utility bills, there is no need to do anything if you wish to remain enrolled. If you'd like to sign up for the program, which automatically debits your checking account, call (847) 724-1700.

What Else Can I Do Using Citizen Self Service?

In addition to paying your bills, CSS also offers the ability to look up business and contractor licenses. Simply choose "Business Licenses" from the CSS Home Page menu.

From the Village President. . .

Thanks To Our Storm Water Task Force



Those of us who lived through the Rain Event of 2008 in mid-September of that year will surely never forget it. The 9.5 inches of rain that fell over the course of two days left parts of Glenview underwater, with several basements flooded and streets closed. It was unprecedented, and it required a creative and proactive response.

After assessing the damage and gathering feedback from affected residents and businesses, we established a **Storm Water Task Force** in January, 2009. For more than a year, this group -- made up of residents who lived in flooded areas and those who did not -- reviewed and analyzed data, evaluated staff proposals, considered costs, and thought long and hard about how best to address flooding issues in our community. They became "experts" on watersheds, waterflow, detention and retention.

This month the final result, a proposed master **Flood Risk Reduction Program**, will be presented to the Board (see page 3 for all the details). It's the culmination of much hard work and dedication, and I wanted to take this opportunity to express our appreciation to the Task Force members -- all volunteers -- who gave up untold hours to tackle this challenging issue and develop workable solutions. And so on behalf of the Board of Trustees, Village staff, and myself, a sincere and heartfelt thank you to:

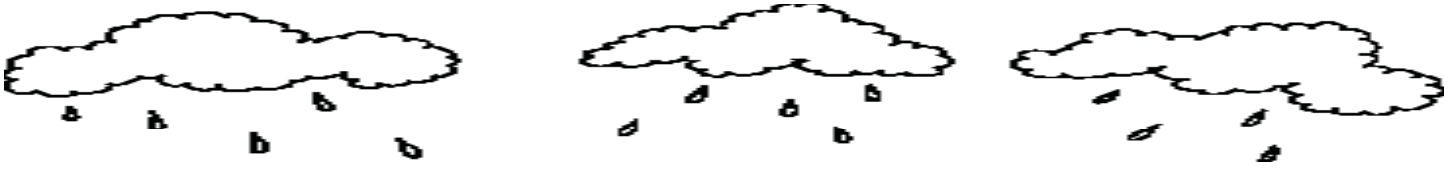

Storm Water Task Force's Flood Risk Reduction Program to be Presented to the Village Board on July 20

In September, 2008, 9.5 inches of rain fell on Glenview over a two-day period, making it a "100-year" storm event (meaning there was a only a one percent chance of receiving such a heavy rainfall that year). The impact was felt by many; common problems included **sanitary sewer backups** resulting from heavy storm water flows leaking into the system, **over-foundation and/or basement flooding** in the floodplain and other low-lying areas, **surface flooding** that temporarily closed streets, and other **minor localized flooding**.

In response, President Kerry Cummings held a community workshop that October to discuss specific resident and business experiences during the storm and to review next steps at the local and regional levels.

With clear evidence of community-wide impacts, President Cummings appointed a **Storm Water Task Force** in January, 2009. Charged with developing and recommending a comprehensive plan to address flooding in Glenview, the Task Force was comprised of 16 residents -- some who lived in flood-prone areas and some who did not. Over the next 13 months, they met with Village staff and a consultant team on 14 occasions to define goals and principles, classify flooding issues, develop conceptual alternatives with timelines and budgets, and draft a plan of action.

Now the Village's Flood Risk Reduction Program -- its storm water Master Plan -- will be presented to the Board of Trustees on Tuesday, July 20. Here are a few highlights:

Quick Win Projects

Among other things, the Program includes several "Quick Win" projects (approved by the Board last fall) which can be completed in 2010 and 2011. These include:

- **Improvements to the East of Harms Sanitary Sewer System (\$4.15 million).** Heavily impacted by the 2008 storm, this area will benefit from new backflow prevention from the main sewer "interceptor," additional sewage storage, and pumping systems to ensure a steady flow is discharged into the interceptor. Project completion is scheduled for the end of 2011.

- **Smaller local storm water system improvements (\$2 million)** throughout the Village that add detention and improve overall system capacity.

Proposed Cost-Sharing Initiatives

The Flood Risk Reduction Program also includes Task

Force recommendations for **cost-sharing initiatives** -- with a 2010 price tag of \$650,000 -- to help homeowners reduce the likelihood of flooding. Although not yet approved by the Board, these include:

- **Overhead sanitary sewer conversions (50/50 cost sharing up to a \$15,000 total project cost).** Homes

with gravity sanitary sewer systems are susceptible to sewage back-up; converting to an overhead system can greatly reduce this risk.

- **Holistic Drainage Inspections (75% Village/25% homeowner cost share).** Throughout the Task Force process, residents often noted that they would be willing to invest in additional flood protection improvements if they had a better understanding of the necessary work, costs and steps involved. This initiative would reduce the cost of hiring an engineer to assess private property flooding issues.
- **Dry-Flood Proofing for Flood Prone Structures (50/50 cost sharing up to \$30,000 total project cost.)** This would aid homeowners living in floodplains in moving ahead with dry-flood proofing projects while longer-term regional floodplain projects are coordinated.

Consideration of the Flood Risk Reduction Program will take place during the Board meeting on July 20 at 7:30 p.m. in the Village Hall, 1225 Waukegan Road. Can't make it? A Few of our "Pet" Summer Projects

Keep 'Em Leashed and Under Control . . . And Don't Forget to Clean Up!



Be a good neighbor! Remember that Village Ordinance requires that pets must be leashed at all times when they're off your property.

And keep in mind: even when they're on the leash, dogs have a lot of curiosity and energy. Make sure that your leashed pet remains **at a comfortable distance from passersby**. You may know that your dog wouldn't hurt a fly, but others may not appreciate the attention. Be considerate -- keep your pet within a foot of your own body, and under control.

Finally, while you're walking your pets, bring extra baggies and be sure to clean up after them.

Dining Al Fresco?



With the warmer weather, more people are taking advantage of the many restaurants in town that offer outdoor dining opportunities.

But keep in mind that Village Code prohibits animals from entering food dispensing establishments - even if they're outdoors (support animals are the exception). Be sure to leash your pet outside of the dining enclosure.

Don't Forget to Tag Fido and Fluffy



Village Ordinance requires that residents obtain a license for pets -- and it's a good idea! There's no fee, and it can help protect your furry friends. If they're lost or injured, it will be easier to identify where they belong and return them to you

more quickly.

Keep Watching Those Weeds



Another reminder that, **under Village Code, weeds and grass may not exceed eight inches in height**. So be a good neighbor and get out that lawn mower and weed wacker. Report any problems to (847) 904-4350.

Groot Update:

Everything You Ever Wanted to Know About Carts (But Were Afraid to Ask)



By now, all Groot customers should have received their new refuse and recycling carts. As of July 1, these standardized carts must be used for solid waste pick up -- **which will be once a week for all customers**. But what should you do with

your old carts? Here are the details -- and a few more frequently asked questions:

About old carts . . .

- **Did you LEASE your old carts?** Groot will begin collecting these on **Monday, July 19**. Please place your old leased containers at the curb on your first garbage day after this date. You may keep your old 18-gallon recycling bin, but it can't be placed out for collection.
- **Do you OWN your old carts/containers?** If so, you may keep them (although they may not be used for pick up). But if you'd like to dispose of them, place them at the curb with a note saying "Please take." Groot will collect them on your next regular pick up day.

About ordering different cart sizes . . .

- Not happy with your cart size(s)? Call the Village at (847) 657-3030 after August 1 to request new sizes.
- Refuse carts are available in 95-, 65-, and 35-gallon sizes. Recycling carts are available in 65- and 35-gallon sizes.
- After September 1, you'll be charged \$25 to switch cart sizes.



About extra carts . . .

- Like an extra cart? Call (847) 657-3030 in September for more information.

And remember . . .

- The Village's agreement with Groot only applies to single-family homes and multi-family buildings with fewer than three units.
- If you're a curbside customer, please have garbage to the curb by 7 a.m. -- and place the carts approximately four feet apart.
- Carts with **green** lids are for recycling. Carts with **black** lids are for refuse.
- If you have more garbage than your cart will hold, please place it at the curb next to the cart.



Work along Waukegan Road is well underway. As noted in last month's *Village Report*, the Illinois Department of Transportation (IDOT) plans to resurface the road between Golf and Willow this summer. And the Village is taking this opportunity to put in some streetscape and safety improvements of its own.

By the middle of July, **Phase I** of the project -- which involves the Village constructing curb bump-outs and raised medians along the road to improve pedestrian and motorist safety -- should be wrapping up.

Phase II -- IDOT's resurfacing work, including closure of 12 curb cuts -- should be underway by July 19. Although such things are always subject to change, it appears that IDOT will be working from south to north; there will be ongoing

lane closures wherever the contractor is working -- regardless of the time of day.

Resurfacing should be complete by early September, at which point the Village will roll out **Phase III**: installing stamped, colored concrete pedestrian crosswalks at five intersections along Waukegan. **Phase IV** will occur simultaneously with Phases II and III and should have minimal impact on motorists; it's primarily related to private property improvements adjacent to the curb-cut closures.

See a Dead Bird?

It can help us monitor West Nile Virus

West Nile Virus generally appears in bird and mosquito populations before it is transmitted to humans -- so monitoring the virus's prevalence in both populations can be a good early indicator of when and where humans will be at risk of West Nile. You can help! Here's what to do if you find a dead bird:

- If you are *east* of Pfingsten, contact the **North Shore Mosquito Abatement District** at (847) 446-9434.
- If you are *west* of Pfingsten, contact the **Northwest Mosquito Abatement District** at (847) 537-2306.

But before you do, make sure that the following conditions are met:

- The bird is dead, but the carcass is in good condition.
- It shows no sign it died of causes other than disease.
- It is a species that is acceptable for testing, including crows, blue jays, grackles, starlings, robins, cardinals, sparrows, finches, hawks and owls.

Summer Is Here! Be a Careful Driver



It's summer! That means more biking, scootering, walking, jogging and playing outside during the long days and evenings. As you drive around town, keep these "safe summer driving" tips in mind:

- Watch for pedestrians and bicyclists crossing the sidewalks and crosswalks *before* you proceed from a stop sign or red light. And look for them before starting a turn.
- Remember to drive 20 mph on all residential streets in Glenview, unless a different speed limit is posted.
- Pay attention to children playing in front yards or at parks -- they might dart into traffic without looking first.

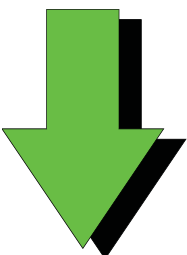
Your attentive driving could prevent an accident! Also, remember that school starts again late in August, so watch for children in school zones and obey the crossing guards.

Sales Tax Rate Drops July 1

Did you know that the sales tax you pay at the register here in Glenview is actually made up of four separate taxes? These include:

- A **State Retail Tax of 6.25 percent** (of which one percent is distributed to the Village).
- A **Regional Transit Authority (RTA) Tax of 1.00 percent**.
- A **Home Rule Sales Tax (HRST)**, levied by the Village itself, of **.75 percent**.
- A **Cook County Tax of 1.75 percent**.

But on July 1, the **County tax dropped to 1.25 percent**. That means that the **total tax on general merchandise is now 9.25 percent** (down from 9.75 percent).

Keep Your Trees Cool!



You aren't the only one who appreciates a cold drink when the temperatures rise. Make sure your trees stay hydrated, too - here's how:

- Water early or late in the day - not during full sun.
- Slowly soak the ground around the tree roots.
- Water newly-planted trees first -- 30 minutes once or twice a week should do it.
- Water mature trees for an hour or two every two-three weeks.
- Water within the "drip line," an imaginary line on the ground that mirrors the edge of the tree's canopy.
- Allow soil to dry between waterings.
- Add three-four inches of mulch around young trees to retain moisture. Spread in a saucer shape bordered by the tree's drip line. Keep mulch away from the trunk.

The Village itself follows these guidelines as it works to water newly-planted trees around town. Our watering trucks are out every day; however, due to the large number of trees, it can be difficult to reach every one of them on a regular basis. You can help by watering any trees in your parkway.

Village Audit, Budget Receive Awards



It's all in the numbers! Recently, the National Government Finance Officers Association (GFOA) presented the Village of Glenview with two awards for its financial management.

The Village's 2008 **Comprehensive Annual Financial Report (CAFR)** received a **Certificate of Achievement for Excellence in Reporting**. The CAFR, essentially the Village's audit, was judged to meet the high standards of the program, including demonstrating a constructive "spirit of full disclosure" to clearly communicate its financial story.

The GFOA also recognized the **Village's 2009 Budget** with a **Distinguished Budget Presentation Award**. To qualify, the Village's budget document had to be proficient as a policy document, a financial plan, an operations guide and a communications device.

Village Manager's Report

- **Update: 2009 Comprehensive Annual Financial Report.** The Village's auditor, Miller Cooper & Company, Ltd., issued an unqualified "clean" audit opinion for the Village for the year ended December 31, 2009.

Village Attorney's Report

- **Update: 2024 Burr Oak.** This partially-constructed home, never completed, poses a health and safety danger. Late in June, the Village was successful in its lawsuit to have the structure demolished.

Approved

- Resolution **declining participation in Cook County's Red Light Camera Program** (which would have resulted in a camera being installed at Landwehr and Lake); requirement that any future installations of red light cameras within the Village's corporate boundaries shall not occur without the prior approval of the corporate authorities. *Vote 4-1 in favor.*
- Contracts, bid awards and purchases:
 - **Glenview Road/Greenwood Road Intersection Improvement Project** through the Illinois Department of Transportation. Budget: \$1,626,892.
 - **Purchase of two fire engines, plus radio and ancillary equipment** via the Northwest Municipal Conference. Budget: \$1,070,600.
 - **Indian Road Reconstruction Project** to PirTano Construction Company. Budget: \$764,858.
 - **Custodial services for Village facilities** to Advanced Cleaning Systems, Inc. Budget: \$274,824.
 - **Supplemental resurfacing projects** to ALamp Concrete Contractors, Inc. Budget: \$151,000.
 - **Crack sealing services** to North Suburban Asphalt Maintenance. Budget: \$108,000.
 - **Fabrication and installation of signs in Gallery Park** to ADCON Signs. Budget: \$81,136.
 - **Purchase of additional refuse and recycling carts** from Rehrig Pacific Company. Budget: \$75,000. This item also included a budget amendment.
 - **Thermoplastic marking services** to Superior Road Striping, Inc. Budget: \$54,000.
- One-year lease with **United Standard Industries, Inc.** for periodic use of the Police Station's firing range and an adjacent storage area. This lease will generate a minimum of \$95,400 annually for the Village.
- Installation of **stamped, colored concrete at the Lake and Waukegan crosswalks.** Budget: \$36,000.
- Memorandum of Understanding with the Baker Development Corporation, which owns 3 Waukegan Road, for **future extension of a landscaped median north of Golf Road.**
- Design and construction expenditures of \$50,000 for the **Glenview/Greenwood Roads Parking Mitigation Project.**

Before You Sprinkle . . .



Now that summer is here, sprinkler systems are being fired up all over the Village. But remember: hot and sunny days also highlight the need for water conservation.

Plan your sprinkling around the cooler parts of the day -- before 10 a.m. and after 4 p.m. This reduces evaporation (making your efforts more efficient) and conserves water. Village ordinance actually prohibits sprinkling between 10 a.m. and 4 p.m., Monday-Friday until September 15. But water evaporates just as quickly on weekends, so use the weekday requirements as your guide even on Saturdays and Sundays.

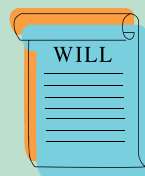
