ARCHITECT'S STATEMENT

The architectural design philosophy for Jackman & Co. is based on enhancing the historic feel of downtown Glenview. Not a period reproduction of an old building. A contemporary interpretation utilizing classic detailing and materials.

We chose to break the Glenview Road façade into two facades keeping the building more in scale with historic Glenview. We chose unifying historic architectural styles that flank a taller entry element making the entry easily identified by guests. This entry element has an arched window transom that is carried through to the interior space. Above the entry doors is a classically detailed marquee also signifying the entrance.

On one side of the entry, the brick is painted a very dark almost black green, Benjamin Moore Essex Green. The windows are casement style trimmed in white. On the other side of the entry, the brick is left natural. The windows are double hung with green awnings above. The double hung windows are painted two colors, white and green. The walls have an applied classic cornice painted tan to match the limestone trim and green.

Like all restaurant buildings there is a large section of potentially blank wall surrounding the kitchen. To break this blank wall up and create interest, we have chosen to create the appearance of a carriage house by adding large decorative doors painted the contrasting green color. Lantern lights hang above.

Brick and stone detailing are important to the architectural design. The brick is laid in a Flemish bond. The openings have soldier coursing at the lintels. The base of the building has a limestone water table starter course. The windows have limestone sills. The entry is trimmed in limestone and has limestone reveals stacked in the brickwork. The fireplace has a picture frame soldier course with stone accents and Edwardian clay chimney pots.

We chose to keep the parapet wall low so as to not create an overly tall building. The parapet is planted with evergreen plant materials so that it is green and lush throughout the year. These plants are irrigated and will have seasonal holiday lighting. The planting hides a screen that in turn hides the mechanical equipment.

Overall, the architecture is appropriate to Ballyhoo's concept of redefining neighborhood feel-good dining and replicating the success of their other locations. It is classic while being updated.

The architecture is appropriate to the downtown Glenview location. It is distinctive and enduring that will result in a project that retains value and meets market and community needs for decades to come.
