The final eligibility list reflects the application of Preference Points, including military points, to eligible candidates per State Statute.

To be hired as a Firefighter/Paramedic, a candidate must successfully pass a background investigation, polygraph examination, oral interview, psychological evaluation and medical examination, including drug test. Failure to successfully pass any of these components shall be grounds for disqualification, and the candidate's name shall be stricken from the list.
