**Glenview Incident Summary
April 16, 2024**

Incidents:

24-15500 Assist Fire

On 04/09/2024 at 1756 hours, Glenview Fire Department responded to the area of Dewes Street and Washington Street for a small fire in a garbage can. It appeared a small cardboard box that had been next to the garbage can had been the source of the fire, but it's contents were undetermined.

24-15507 Assist Fire

On 04/09/2024 at 1838 hours, Glenview Fire Department responded to a business in the 1300 block of Patriot Boulevard, for a dumpster fire. Employees extinguished the fire prior GFD arrival. Employees did not see anyone in the area prior to the fire and nothing appeared suspicious.
