**Glenview Incident Summary
April 2, 2024**

Incidents:

24-13348 Intimidation

On 03/26/2024 at 1320 hours, an employee for a business in the 1800 block of Milwaukee Avenue reported they received a phone call from an unknown male individual who stated they were being investigated for prostitution and needed to pay a \$10,000 bond in lieu of being arrested. The employee did not pay any money and blocked the number.
