# GLENVIEW FIREFIGHTERS' PENSION FUND BOARD OF TRUSTEES MEETING JANUARY 21, 2014

**Call to Order**: The meeting was called to order at 7:35 a.m. in the 2<sup>nd</sup> floor conference room at the Glenview Fire Department Headquarters 2500 E. Lake Avenue temporary location. On roll call the following were:

**Minutes:** Trustee Rusher called for a review of the minutes of October 22, 2013. Trustee Rounsfull motioned to approve as amended the minutes of October 22, 2013; Trustee Dvorak seconded and the vote was all ayes, no nays and the minutes of October 22, 2013 were accepted.

#### Financial Reports/

**Contribution Review:** Tom Sawyer from Sawyer Falduto Asset Management distributed and provided an overview of the December 31, 2013 Quarterly Investment Performance Report. For the quarter ending December 31, 2013, the fund had a total return of 4.58% (gross of fee) as compared to the account benchmark return of 4.42%. As of December 31, 2013 the net position held in Trust for Pension Benefits is \$62,072,711.42.

After a review of the December 31, 2013 Quarterly Investment Performance Report Trustee Rounsfull motioned to accept the December 31, 2013 Quarterly Investment Performance Report, Trustee Frank seconded and a roll call was taken and the vote was all ayes, no nays and the motion passed.

Derek Flessner of Lauterbach & Amen distributed the Monthly Financial Report for the Month Ended December 31, 2013. Derek provided an overview of the contents. Trustee Dvorak motioned to accept the Lauterbach & Amen Monthly Financial Report for the Month Ended December 31, 2013. Trustee Rounsfull seconded and a roll call was taken and the vote was all ayes, no nays and the motion passed.

Trustee Rounsfull motioned to accept Derrick Novak's Application for Membership effective January 8, 2014 at Tier 2; Trustee Dvorak seconded and the vote was all ayes, no nays and the motion passed.

Steven Roberts was also hired January 8, 2014. His Application for Membership has not been received. This will be placed on the April agenda.

Brian Stokes' independent medical examinations are being coordinated through Woodlake Medical Management. Brian's paperwork is still pending.

FF/PM Troy Boyer retired working his last day January 3, 2014. Troy's date of hire was 01-01-1985 working 29 years. His effective date of pension is January 4, 2014 with a total pensionable salary of \$97,474.39. Trustee Dvorak motioned to approve Troy Boyer's effective pension date January 4, 2014 with a total pensionable salary of \$97,474.39; Trustee Caplis seconded and a roll call was taken and the vote was all ayes, no nays and the motion passed.

Captain Terry Wilson retired working his last day January 8, 2014. Terry's date of hire was 09-01-1985 working 28 years 4 months. His effective date of pension is January 8, 2014 with a total pensionable salary of \$123,353.59. Trustee Dvorak motioned to approve Terry Wilson's effective pension date January 8, 2014 with a total pensionable salary of \$123,353.59; Trustee Caplis seconded and a roll call was taken and the vote was all ayes, no nays and the motion passed.

Other Business: Lauterbach and Amen, LLP submitted a proposal to provide actuarial consulting services. Todd Schroeder with Lauterbach and Amen attended the meeting and provided an overview of his services. The fees are the same at \$2,250.00 per year. After a discussion Trustee Rounsfull motioned to engage Todd Schroeder with Lauterbach & Amen, LLP services for the 2013 Actuarial Report; Trustee Frank seconded and a roll call was taken and the vote was all ayes, no nays and the motion passed.

Todd Schroeder will disseminate information to the Board at the April meeting.

Attorney Karlson will notify Art Tepfer the Board chose another vendor for actuarial consulting services.

Attorney Karlson provided to Trustee Rusher & letter clarifying the calculation of pensionable salary. Trustee Rusher had been asked for clarification by the Village Human Resources Director.

Attorney Karlson sent a letter December 23, 2013 regarding Jennifer Neihengen to Kamerlink, Stark, McCormak. It indicated all future payments regarding the withholding order will be paid directly to the State Disbursement Unit.

Leon Olsen requested retiree contact information. Mr. Olsen's request was denied. Mr. Olsen was informed he can choose to have his personal contact information published in the pension minutes for others to contact him.

The Board is waiting for additional information from Bellwood regarding David Grady's reciprocity request.

The 2014 Annual Affidavit forms will be sent for distribution to Derek Flessner with Lauterbach & Amen. The forms will be included with the February paystub mailings.

Lauterbach & Amen will mail Annual Statements to active members by June 2014.

Current Trustee Tom Dvorak's term expires in April 2014. In February 2014 Trustee Rusher will start the election process for the one active firefighter pension Board Trustee position.

Attached is the Annual Benefit Increases effective January 1, 2014. Trustee Rounsfull motioned to approve the attached COLA document; Trustee Dvorak seconded and a roll call was taken and the vote was all ayes, no nays and the motion passed.
