The Contractor must submit to the Village a current Certificate of Eligibility issued by the Illinois Department of Transportation for Work Category 003 (Hot-Mix Asphalt Plant Mix) and or Work Category 005 (HMA paving) prior to obtaining bidding documents for this project.

Please note: **Bid submissions received from firms that do not have a Certificate of Eligibility for the Work Category identified herein will be returned to the bidder unopened.**

Scope of work includes: Approximately 40,000 LF of road rehabilitation / resurfacing, sanitary/ storm sewer system repairs, driveway and parkway restoration work.

We do not accept cash or credit cards.

All bids shall be accompanied by a Bid Bond, Certified or Cashier's Check made payable to the Village of Glenview for not less than five percent (5%) of the bid amount. The successful bidder must furnish a satisfactory performance bond and a contract bond in the full amount of the bid.

**All work under this contract shall comply with the Prevailing Wage Act of the State of Illinois, 820 ILCS 130/0.01 et seq. and Employment of Illinois Works on Public Workers Act (30 ILCS 570/).**

Offers may not be withdrawn for a period of ninety (90) days after closing date without the consent of the Village of Glenview Board of Trustees.

Any Bid submitted unsealed, unsigned, fax transmissions or received subsequent to the aforementioned date and time, may be disqualified and returned to the bidder.
