**MANDATORY** PRE-BID MEETING WILL BE HELD ON **SEPTEMBER 4, 10:00 A.M.**, AT GLENVIEW'S PUBLIC WORKS CAMPUS, 1333 SHERMER RD., GLENVIEW, IL 60026. A SITE WALK-THRU WILL COMMENCE FOLLOWING THE PRE-BID MEETING. THIS WILL BE THE ONLY OPPORTUNITY TO VIEW THE FACILITY.

Scope of work: The project has two parts where first phase includes the installation of electrical power and lighting and for future loads to an existing tent to be used for road salt storage at the public works campus. The second phase includes the installation of electrical power and natural gas piping for a tent to be moved from another site to the public works campus. Tent relocation will be performed by others, but this project will include the disconnection and removal of existing gas appliances, electrical panel board, and loads from the current location of the tent just prior to moving and the reconnection of electrical lighting, panel board, and gas appliances after this tent has been re-erected at its new location.

All bids shall be accompanied by a Bid Bond, Certified or Cashier's Check made payable to the Village of Glenview for not less than five percent (5%) of the bid amount. The successful bidder must furnish a satisfactory performance and payment bond in the full amount of the bid.

**All work under this contract shall comply with the Prevailing Wage Act of the State of Illinois, 820 ILCS 130/0.01 et seq. & the Employment of Illinois Workers on Public Works Act (30 ILCS 570/0.01 et seq.).**

Offers may not be withdrawn for a period of ninety (90) days after the bid date without the consent of the Village.

Any Bid submitted unsealed, unsigned, fax transmissions or received subsequent to the aforementioned date and time, will be disqualified and returned to the bidder.

The Village reserves the right to reject any and all bids or parts thereof, to waive any irregularities or informalities in bid procedures and to award the contract in a manner best serving the interest of the Village
