SUBJECT: Consideration of a Resolution authorizing a bid award and approving a contract with Lenny Hoffman Excavating, Inc. of Wilmette, Illinois for the Spruce Street, Birchwood Court, and Parkview Road Improvement Projects in the amount of \$2,331,272 plus a three percent (3%) contingency, for an amount not to exceed \$2,401,201.

PURPOSE AND ACTION REQUESTED:

Village staff requests Village Board consideration of a Resolution authorizing a bid award and approval of a contract with Lenny Hoffman Excavating, Inc., ("Lenny Hoffman") of Wilmette, Illinois for the Spruce Street, Birchwood Court, and Parkview Road Improvement Projects ("Projects") in the amount of \$2,331,272 plus a three percent (3%) contingency, for an amount not to exceed \$2,401,201.

PROPOSAL AND BACKGROUND:

The Village is committed to the investing in replacement and rehabilitation of aging surface and underground infrastructure. The proposed Projects include approximately 0.25 miles of improvements on Spruce Street and Birchwood Court, south of Harrison Street and east of Shermer Road and 0.20 miles of improvements on Parkview Road from Golf Road though McArthur Drive to the cul-de-sac (see Attachment 2 Projects Location Maps).

Scope of Work - Spruce Street, Birchwood Court, and Parkview Road Improvements:

The following major improvements are included in this contract:

- Water main improvements include the installation of approximately 650 feet of 12-inch and 1500 feet of 8-inch Polyvinyl Chloride (PVC) water mains and services. The new water main will replace the existing, deteriorated water main.
- The proposed storm sewer improvements consist of upgrading of 2200 feet of storm sewer system ranging from 12 to 24-inch pipe.
- The proposed sanitary sewer improvements consist of sanitary manhole repairs and replacement of sanitary services, if necessary.
- The proposed pavement improvements consist of trench patching over utility installations and the entire stretch of Spruce Street from Harrison Street to Colfax Avenue will receive a full-depth resurfacing.

PROJECTS TIMELINE:

The following steps are required to complete the Spruce Street, Birchwood Court, and Parkview Road Improvements

- Bid notice published in local newspaper January 27, 2022
- Bid opening date February 10, 2022
- Bid award April 5, 2022
- Resident Pre-Construction Meeting April 28, 2022
- Approximate starting date of construction May 16, 2022
- Approximate completion date September 23, 2022

DISCUSSION:

On February 10, 2022, five (5) bids from responsive and responsible contractors for the above references Projects were submitted to the Village. The contractors and total bid amounts submitted were as follows:

Lenny Hoffman was the lowest bidder with a bid price of \$2,367,222, for the project bid. Hoffman is prequalified by IDOT to complete the components of work included in this Project. Hoffman has previously worked in the Village of Glenview, and all their work has been satisfactory.

BUDGET:

Funding was approved by the Village Board in conjunction with the FY2022 CIP budget. The requested contract approval is \$2,331,272 plus a three percent (3%) contingency, for an amount not to exceed \$2,401,201. The lowest bid amount submitted was approximately \$75,000 higher than originally estimated due to higher material and labor costs associated with the current market conditions. Staff reviewed the bid prices and was able to achieve approximatly \$40,000 of savings by substituting pipe material for the 18" storm sewer. Although the resulting amount is still approximately \$35,000 over the estimated budget for these Projects several of the water main replacement components are able to be funded through fund balance in the Water Fund. Staff continues to monitor project pricing and thus far has been able to make minor adjustments to account for constant increases in construction bid costs.

The proposed improvements are to be funded by the Village as follows:


RECOMMENDATION:
