Application to Participate in the Village of Glenview Solid Waste Services Program

On March 15, 2011, the Village of Glenview Board of Trustees amended Chapter 58 of the Municipal Code allowing multi-family residential properties with three (3) or more units to voluntarily participate in the Village's solid waste services program. In order to receive these services, property must:

- have participation from all households within the multi-family property
- apply to the Village to receive collection and disposal services from the waste disposal firm duly appointed by the Village, which application shall be approved by the Village at its sole discretion
- pay the Village for Village refuse and recycling containers
- be capable of receiving curbside refuse and recycling pick-up

Participation is voluntary. However, multi-family residential properties must have participation from all units in the development and will be required to permanently remain in program.

Village's Solid Waste Services Program

The current Village Solid Waste Services Agreement incorporates 11,500 residential units. Annual price increases are in accordance with the Consumer Price Index (CPI) and shall not exceed 2.5%. If the CPI decreases, there would be no rate adjustment for that year of service. The program also includes:

- ✓ Once-a-Week Collection The Village hauler will only collect refuse and recycling once per week
- ✓ **Individual Billing -** The Village hauler will bill each residence quarterly
- ✓ Senior Discount Residents 65 and older qualify for a ten percent senior discount
- ✓ Village Carts All new participants will be required to purchase Village refuse and recycling carts. Standardizing collection makes it quicker, easier, and more efficient for waste hauling teams resulting in cost containment.
- ✓ **Compressed Natural Gas (CNG) Trucks -** All trucks serving the Village for refuse and recycling pick-up will be fueled by CNG or a similar environmentally sensitive fuel equivalent approved by the Village Manager.

Application Process

Step One

Application is completed and submitted to the Director of Public Works



Step Two

The Director of Public Works reviews application to ensure criteria is met. If approved, an invoice for the refuse and recycling carts is created and returned with the approved application.



Upon cart invoice payment, refuse and recycling carts are delivered to each property. A letter will be mailed to each new property notifying the new participants of the program start date and the Village's hauler will be notified.
