**Glenview Incident Summary
April 23, 2024**

Incidents:

24-16430 Unlawful Use of a Credit Card

On 04/15/2024 at 1450 hours, an employee for a business in the 900 block of Shermer Road, reported on 10/02/2023, a subject ordered four tires over the phone and paid via credit card. They brought in the vehicle later that day to have the tires installed. On 10/07/2023, the company received notice that the credit card was stolen and they had a charge back of \$1,325.30. The same offender repeated the incident on 10/05/2023, giving the business a loss of \$1,320.56 (24-16569). Complaints will be signed

24-16655 Theft

On 04/16/2024 at 2230 hours, a Northbrook resident reported shopping at a business in the 2700 block of Pfingsten Road between 1900-1930 hours. They left her Apple Iphone in the cart and walked away from it. When they returned, the phone was gone. Complaints will be signed.

24-16702 Criminal Damage to State Supported Property

On 04/17/2024 at 0905 hours, Glenview Park District employees reported an unknown offender damaged the playground equipment at Indian Ridge Park, 2504 Indian Ridge Drive. Several words and drawings were etched with a sharp object onto the slides, picnic table, and sides of the equipment. The damage was discovered on 04/15/2024 and they are not sure when it occurred. 24-16709 Retail Theft

On 04/17/2024 at 0959 hours, an employee for a business in the 2500 block of Waukegan Road, reported observing a Chicago resident conceal bottles of alcohol inside the store. Officers spoke with the subject who admitted to concealing the alcohol and turned the items back over to the business. They were issued a Village Ordinance citation for Theft and was given a formal trespass warning not to return.

24-16761 Disorderly Conduct

On 04/17/2024 at 1555 hours, employees for a business in the 600 block of Waukegan Road, reported a male white subject, 50-55 yoa, wearing a black baseball cap, back shorts, black shirt, and glasses, was standing near the bushes on the north side of the property yelling at the employees. He then left the area. Officers were unable to locate the male. This is the second incident with the same male yelling at the business.

On 04/17/2024 at 2105 hours, employee a business in the 1600 block of Milwaukee Avenue, reported a male black, late 40's, 5'07"-5'10", 200 pound, full beard, short hair with balding on top, followed a guest to their room and blocked them from entering. Officers were unable to locate the offender.

24-16848 Disorderly Conduct

On 04/18/2024 at 0501 hours, staff for a business in the 1500 block of Milwaukee Avenue, observed a Rockford resident in the business. They removed their shoes and was unbuttoning and rebuttoning their shirt. When approached by staff, they appeared intoxicated. TStaff checked surveillance video which showed the subject exposing his penis and masturbating. Officers spoke with the subject who denied any inappropriate behavior. They were given a trespass warning not to return.

24-16867 Battery

On 04/18/2024 at 0909 hours, an employee for a business in the 1500 block of Milwaukee Avenue, reported a customer was upset about an issue with the building. The customer was yelling at the employee, calling them names. They left the business and then immediately returned and slapped the employee. The customer left the scene and later turned themselves into the police department, where they were issued a Village Ordinance citation for Battery.

24-16869 Aggravated Identity Theft

On 04/18/2024 at 0917 hours, a resident of the 1600 block of Glenview Road reported they did not receive their IRS refund for the 2023 filing year. After corresponding with the IRS, they learned \$91,278 was sent to a "Preparer's Account" through Civista Bank, which they do not own. They advised the IRS showed the taxes were filed using their information, but a different phone number and email address.

24-16877 Burglary from Vehicle

On 04/18/2024 at 1028 hours, the owner of landscaping trailer reported parking the landscaping trailer on the street in the 1400 block of Kaywood Lane while doing yardwork in the area. At 1020 hours, a witness observed a white mini van pull up to the trailer and two male blacks exited, then proceeded to remove equipment from the trailer. One of the males had dreadlocks and the other was wearing a ski mask. The driver is unknown and did not get out of the vehicle. Total loss of equipment is \$4,600.

24-16921 Battery

On 04/18/2024 at 1625 hours, an employee for a business in the 1700 block of Chestnut Avenue reported on 04/13/2024, they worked with a fellow employee. The other employee became upset and pushed the complainant against the wall, yelling at them. The offender was seen throwing the complainant's bag into the roadway on Chestnut Avenue, which damaged the property inside the bag.

24-17000 Battery

On 04/16/2024 at 0713 hours, an Arizona resident reported staying at a hotel in the 2600 block Lehigh Avenue, with their two dogs. They left the dogs in the room while they left to get breakfast. When they returned, the neighboring guest, a Michigan resident, opened their door and yelled about the dogs barking. They spit and hit each other during the course of the argument. No complaints to be signed.

24-17051 Harassment by Telephone

On 04/19/2024 at 1343 hours, a resident of the 0 hundred block of Park Drive, reported having an argument with a Northbrook resident resulting in them calling and texting multiple times. The Glenview resident wanted them to stop calling. Officers advised them to stop calling and they complied.

24-17200 Identity Theft

On 04/20/2024 at 0824 hours, Jason Rose, M/50, 936 Echo Lane, Glenview IL, reported he contacted SiriusXM radio to transfer his service from his old car to his new car. He was told by an unknown male, with an Indian accent, that his needed to renew the service and provided his credit card, bank account, and other personal information. After the service did not transfer, he contacted SiriusXM again and learned they had not record of Rose calling. An attempted withdrawal of \$350.00 from Rose bank account was made. No financial loss at this time, complaints will be signed.

24-17249 Retail Theft

On 04/20/2024 at 1611 hours, officers responded to a business in the 2700 block of Pfingsten Road, for a delayed retail theft. Loss Prevention Officer for the business stated while reviewing store security footage, they observed on 04/17/2024 at 2100 hours two unknown male black suspects removed numerous bottles of alcohol and left in a black SUV, eastbound on Willow Road. They recognized the suspects from prior retail thefts. Total loss is \$1,196.73.

24-17361 Theft

On 04/21/2024 at 1111 hours, a resident of the 200 block of Washington Street reported communicating with Elon Musk via "X" and he deceived her out of \$1200. They reported Musk contacted her on "X" about a month ago and then asked if they could communicate via the app "Signal". Throughout the month, they sent him gift cards (Apple, Visa, Steam) valued at \$600 and an addition \$600 through Bitcoin. They stated they just realized they were not communicating with Musk and does not know who the offender is.

24-17374 Theft

On 04/21/2024 at 1405 hours, an agent for a business in the 1800 block of Waukegan Road, reported a Glenview resident was trying to return a vape unit that was missing parts. They stated the subject often steals small items and advised they no longer wants them at the store. The subject was given a trespass warning not to return and they left without incident.

24-17417 Disorderly Conduct

On 04/21/2024 at 1939 hours, Dispatch received a phone call from an unknown male stating he was holding three girls hostage and had explosives in the residence. The caller told Dispatch that there were 5 men inside, armed with AR15's and handguns and that one witness was shot. Officers responded to the 900 block of Pleasant Lane and spoke with the homeowners, who advised everyone was ok inside the residence and they did not make any calls asking for help. There has been a previous occurrence at the same residence for "swatting" and all parties at the home denied knowing who made the call.

24-17469 Criminal Damage

On 04/22/2024 at 0528 hours, a small pile of mulch was seen smoking behind the bathrooms at Johns Park, 2101 Central Road. The Glenview Fire Department extinguished the pile. A small patch of grass was damaged, and the Park District was notified.

24-17504 Theft

On 04/22/24 at 1145 hrs, a resident of the 4100 block of Crestwood Dr, reported receiving and responding to a spam text "73101" that had them link their cryptocurrency account to a wallet with the Department of Justice. They googled KuCoin scam and saw articles from the Securities Exchange Commission and believed the text to be true. They transferred \$10,000 worth of currency and now it is gone. Total loss is \$10,000.

24-17529 Identity Theft

On 04/22/24 at 1509 hrs, a resident of the 300 block of Spruce St reported an unknown offender opened up a Comcast account in their name using an address in Kankakee, IL. There is no monetary loss at this time.

24-17579 Criminal Defacement

On 04/22/24 at 1926 hrs, a resident of the 100 block of Center Branch Rd, reported finding graffiti sprayed painted on the fence in the 2400 block of Westleigh Dr. An unknown offender spray painted "LKK" and "KK" in black paint on the fence.

On 04/22/24 at 1804 hrs, a Glenview resident reported finding graffiti spray painted on a fence in Techny Basin, 1893 Westleigh Dr. The graffiti was located on a wooden fence and consisted of a crown and "SG".
