**Glenview Incident Summary  
April 30, 2024**

**Incidents:**

**24-17770                      Disorderly Conduct**

On 04/24/2024 at 0808 hours, a resident of the 3700 block of Lindenwood Lane reported a large dark colored SUV drove by his residence with the lights off. Someone from the vehicle threw eggs at the house.
